COMPLIANCE AGREEMENT

- Rights of participation in this camp are forfeited after two days of absence by the camper
- No profanity, verbal abuse, physical abuse, or abuse of equipment or facilities will be tolerated
- No electronic devices or recreation activities other than those permitted by the camp coordinator or camp host are allowed during the camp
- No camper will be allowed to leave the camp prior to the concluding session without written parental consent
- Report any illnesses or injuries to camp staff before or during this camp
- Staff and volunteers of BETHEL are not responsible for items stolen, damaged, or lost during the camp
- The camp staff may establish additional rules as required to enhance the safety of the camp. Non-compliance will result in dismissal at the discretion of the camp coordinator and camp host without refund

GENERAL RELEASE AND HOLD HARMLESS AGREEMENT & MEDICAL TREATMENT AUTHORIZATION AND POWER OF ATTORNEY

I, the undersigned, am the parent or legal guardian of the aforementioned child participant (the "minor"), who desires to participate in Bethel Kids Day Camp 2017 and all of its activities at Bethel Chinese Christian MB Church located at 3215 School Ave, Vancouver, Canada from August 14, 2017 to August 18, 2017 (hereinafter collectively referred to as the "Activities") organized and operated by Bethel Chinese Christian MB Church.

I understand and acknowledge that Bethel Chinese Christian MB Church will not allow the minor to participate in the Activities without releasing and holding Bethel Chinese Christian MB Church harmless from any liability arising out of participation in the Activities. I understand that there may be risks involved in the minor's participation in the Activities and fully assume such risks.

I REQUEST THAT BETHEL CHINESE CHRISTIAN MB CHURCH ALLOWS THE MINOR TO PARTICIPATE IN THE ACTIVITIES, AND IN CONSIDERATION THEREOF AGREE HEREBY TO RELEASE AND FOREVER DISCHARGE BETHEL CHINESE CHRISTIAN MB CHURCH, ITS OFFICERS AND DIRECTORS, AND ITS EMPLOYEES, AGENTS AND ANY PARTIES VOLUNTEERING ON BEHALF OF THE CHURCH FROM ALL ACTIONS, CAUSES OF ACTION, INJURIES, CLAIMS, DAMAGES, LOSS, COSTS OR EXPENSES OF ANY KIND RESULTING FROM OR RELATED TO ANY SUCH ACTIVITIES IN WHICH THE MINOR PARTICIPATE. I UNDERSTAND THAT THIS IS A FULL AND COMPLETE RELEASE OF ALL INJURIES AND DAMAGES WHICH I OR THE MINOR MAY SUSTAIN AS A RESULT OF HIS OR HER PARTICIPATION IN ANY OF THE ACTIVITIES, REGARDLESS OF THE SPECIFIC CAUSE THEREOF.

I further acknowledge and agree that I have given my consent for the minor to participate in the Activities and to remain in the custody of Bethel Chinese Christian MB Church and its representatives while participating in the Activities.

In the event the minor suffers an injury or condition during his or her participation in the Activities, including transportation to and from the Activity, which may endanger his or her life, cause disfigurement, physical impairment, or undue discomfort if medical treatment is delayed, and reasonable attempts to contact me and the designated emergency contact person have been unsuccessful, I hereby appoint eligible members of Bethel Chinese Christian MB Church leadership team as my agent(s) to act for me and in my name (in any way I could act in person) to make any and all decisions for the minor concerning his or her personal care, medical treatment, hospitalization and health care. This power of attorney and delegation of authority shall terminate when the agent is first able to contact me or the designated emergency contact person.

This agreement is binding on all the minor's heirs, successors and personal representatives.
